IT IS THEREFORE ORDERED, by the Administrator of the Texas Alcoholic Beverage Commission, pursuant to Subchapter B of Chapter 5 of the Texas Alcoholic Beverage Code and 16 TAC §31.1, of the Commission Rules, that your permit(s) and/or license(s) is/are hereby **CANCELLED**.

This Order will become **Final and Enforceable** on the 10th day of July, 2009, unless a Motion for Rehearing is filed **before** that date.
