



MANUFACTURER PERMITS



DISTILLED SPIRITS



DISTILLER'S AND RECTIFIER'S PERMIT (D)

Permit authorizes permit holder to manufacture distilled spirits and rectify, purify, and refine distilled spirits, mix liquor, bottle and package the permit holder's finished products and sell to wholesalers and qualified individuals outside this state and import from nonresident seller distilled spirits for manufacturing and rectifying purposes. Permit Fee: \$3,350

WINERY PERMIT (G)

Permit authorizes holder to manufacture, bottle, label and package wine containing not more than 24% alcohol by volume; sell or buy wine from permit holders authorized to purchase and sell wine, including wholesalers, winery and wine bottler's permittees; sell wine to ultimate consumers for consumption on the winery premises or in unbroken packages for off-premise consumption; and dispense free wine for consumption on the winery premises. Permit Fee: \$851

WINE



BEER & MALT BEVERAGES



MANUFACTURER'S LICENSE (BA)

License authorizes the holder to manufacture beer and sell it to holder of general, local, and branch distributor's license and to qualified persons outside the state, and to dispense beer for on-premise consumption. Permit holder may enter into an alternating brewery proprietorship or contract brewing arrangement. License Fee 1st Establishment: \$2,151

BREWER'S PERMIT (B)

Permit authorizes holder to manufacture ale and malt liquor and sell the ale and malt liquor only to wholesale permit holders in this state or to qualified persons outside the state. If annual production of ale together with annual production of beer by the holder of a manufacturer's license at the same premises does not exceed a total of 225,000 barrels, the holder may sell ale produced on the brewer's premise under the permit to ultimate consumers on the brewer's premises. Combined sales of ale together with sales of beer to the ultimate consumer may not exceed 5,000 barrels annually. Permit Fee: \$3,576

BREW PUB LICENSE (BP)

Must hold a Retail Dealer's On-Premise License (BE), a Wine & Beer Retailer's Permit (BG) or a Mixed Beverage Permit (MB.) License authorizes the holder to manufacture, brew, bottle, can, package and label malt liquor, ale, and beer; sell or offer without charge, on the premises of the brewpub, to ultimate consumers for consumption on or off those premises, malt liquor, ale or beer produced by the holder in or from a lawful container, to the extent the sales or offers are allowed under the holder's other permits or licenses; must be held with permit or license authorizing on-premise consumption. Total production cannot exceed 10,000 barrels for each licensed brewpub. Permit holders who also hold a wine and beer retailer's permit and who sell alcoholic beverages manufactured only on the brewpub's premises may sell malt liquor or ale produced under the license to retailers and private clubs and beer to distributors, retailers, and private clubs or to qualified persons for shipment and consumption outside the state. License Fee: \$1,426



DISTRIBUTOR/ WHOLESALE PERMITS



WHOLESALE



WHOLESALE'S PERMIT (W)

Permit authorizes holder to purchase and import distilled spirits, malt liquor, ale and vinous liquor from Nonresident Seller permittees, Brewer's Permit, other wholesalers and Class B Wholesalers, and sell same to retailer and wholesalers authorized to sell same. Permit Fee: \$4,451

GENERAL CLASS B WHOLESALE PERMIT (X)

Permit authorizes holder to purchase and import malt liquor, ale and vinous liquor from Nonresident Sellers, Brewer's permittees, other wholesalers and Class B Wholesaler's, and sell same to retailers and wholesalers authorized to sell same. Permit Fee: \$1,251

GENERAL DISTRIBUTOR'S LICENSE (BB)

License authorizes holder to sell beer to other distributors, local distributors, private clubs and retailers in the unbroken original packages from the manufacturer or distributor, to serve free beer for consumption on the licensed premises; distribute and sell to qualified persons for shipment outside the state. License Fee: \$1,301

BRANCH DISTRIBUTOR'S LICENSE (BC)

Must hold a General Distributor's License (BB). License allows the holder of a general distributor's license to expand his distributing business at another location in any county where the sale of beer is legal. License Fee: \$851

DISTRIBUTOR



IMPORTER'S LICENSE (BI)

Must hold a Manufacturer's License (BA) or General Distributor's License (BB). May be issued only to a holder of a manufacturer's or distributor's license and authorizes holder to import beer from outside the State of Texas from the holder of a non-resident manufacturer's. License Fee: \$318

LOCAL DISTRIBUTOR'S PERMIT (LP)

Must hold a Package Store Permit (P). Permit authorizes Package Store permittees to sell alcoholic beverages to Mixed Beverage, Private Club Registration and Private Club Exemption Certificate permittees. Permit Fee: 652





RETAILERS ON PREMISE PERMITS



BEER

RETAIL DEALER'S ON-PREMISE LICENSE (BE)

License authorizes holder to sell beer for consumption on or off premises where sold in a lawful container to the ultimate consumer but not for resale. Requires adequate seating area for customers. License Fee: \$853/ \$2,553*



BEER, MALT BEVERAGES & WINE

WINE AND BEER RETAILER'S PERMIT (BG)

Permit authorizes the holder to sell for consumption on or off the premises where sold but not for resale, beer, ale, malt liquor and wine not more than 14% or 17% (Section 251.81). Requires adequate seating area for customers. License Fee: \$853/ \$2,553*

*Applies to BEXAR, DALLAS, HARRIS, & TARRANT Counties

DISTILLED SPIRITS, MALT BEVERAGES, & WINE

MIXED BEVERAGE PERMIT (MB)

Permit authorizes the holder to sell mixed beverages from unsealed containers and wine, beer, ale and malt liquor in containers of any legal size for on-premise consumption. Initial Permit Fee: \$6,602



MIXED BEVERAGE RESTAURANT PERMIT WITH FB (RM)

Permit authorizes a restaurant located in an area voted wet for the legal sale of mixed beverages in restaurant by food and beverage certificate holder to sell mixed drinks, wine, beer, ale and malt liquor for consumption on the premises of the restaurant. Initial Permit Fee: \$6,602

BREW PUB LICENSE (BP)

Must hold a Retail Dealer's On-Premise License (BE), a Wine & Beer Retailer's Permit (BG) or a Mixed Beverage Permit (MB.) License authorizes the holder to manufacture, brew, bottle, can, package and label malt liquor, ale, and beer; sell or offer without charge, on the premises of the brewpub, to ultimate consumers for consumption on or off those premises, malt liquor, ale or beer produced by the holder in or from a lawful container, to the extent the sales or offers are allowed under the holder's other permits or licenses; must be held with permit or license authorizing on-premise consumption. Total production cannot exceed 10,000 barrels for each licensed brewpub. Permit holders who also hold a wine and beer retailer's permit and who sell alcoholic beverages manufactured only on the brewpub's premises may sell malt liquor or ale produced under the license to retailers and private clubs and beer to distributors, retailers, and private clubs or to qualified persons for shipment and consumption outside the state. License Fee: \$1,426



PRIVATE CLUB PERMITS

PRIVATE CLUB REGISTRATION PERMIT (N)
Permit authorizes alcoholic beverages belonging to members of the club to be served for on premise consumption only to its members, their family and their guests. Permit fees vary based on membership options. See our **Fee Chart**.

PRIVATE CLUB EXEMPTION CERTIFICATE PERMIT (NE)
Permit authorizes club to serve alcoholic beverages to its members and their guests and issued in compliance with 32.11-fraternal and veterans organizations. Exempt from permit fees.

**PRIVATE CLUB BEER AND WINE
PERMIT (NB)**

Permit allows holder to have activities authorized under a Private Club permit restricted to the storage and service of wine, beer and malt liquor for club members.
Permit Fee: \$3,901



RETAILERS OFF PREMISE PERMITS



BEER

RETAIL DEALER'S OFF-PREMISE LICENSE (BF)

License authorizes holder to sell beer in a lawful container direct to the consumer but not for resale and not to be opened or consumed on or near the premises where sold. License Fee: \$673



BEER, MALT BEVERAGES & WINE

WINE AND BEER RETAILER'S OFF-PREMISE PERMIT (BQ)

Permit authorizes the holder to sell for off-premise consumption only in unbroken original containers, but not for resale, wine, beer, and malt liquors containing alcohol in excess of one-half of one percent (1/2 of 1%) by volume and not more than 14% or 17% of alcohol by volume (Section 251.81). Permit Fee: \$673

WINE

WINE ONLY PACKAGE STORE(Q)

Permit authorizes the holder to sell ale, malt liquor, wine and vinous liquors on or from licensed premises at retail to consumer for off-premise consumption. The holder of a wine-only package store permit whose premise is located in a wet area allowing the legal sale of wine for off-premise consumption only as determined by an election held under Section 251.19 may only purchase, sell, or possess vinous liquor only-- no ale or malt liquor on those premises. Permit Fee: \$703



DISTILLED SPIRITS, MALT BEVERAGES & WINE



PACKAGE STORE PERMIT (P)

Permit authorizes the holder to sell liquor, malt and vinous liquors on or from licensed premises at retail to consumer for off-premise consumption. Permit Fee: \$1,501

LOCAL DISTRIBUTOR'S PERMIT (LP)

Must hold a Package Store Permit (P). Permit authorizes Package Store permittees to sell alcoholic beverages to Mixed Beverage, Private Club Registration and Private Club Exemption Certificate permittees. Permit Fee: \$652



NON-RESIDENT PERMITS



DISTILLED SPIRITS & WINE



NONRESIDENT SELLER'S PERMIT (S)

Permit authorizes out of state distillers, wineries, importers, and brokers to solicit, take orders, ship liquor or cause liquor to be shipped to permittees authorized to import liquor into Texas. A Nonresident Seller's Permit can be issued to persons inside the state, as well as to persons outside the state. If permit is issued to persons inside the state they cannot take physical possession, store, or transport the liquor. Permit Fee: \$676

WINE

OUT-OF-STATE WINERY DIRECT SHIPPER'S PERMIT (DS)

Permit authorizes the holder to sell and deliver wine that is produced or bottled by the permittee to an ultimate consumer located in wet or dry areas in the State of Texas. Delivery must be made by the holder of a carrier's permit. Permit Fee: \$526



BEER & MALT BEVERAGES



NONRESIDENT BREWER'S PERMIT (U)

Must also hold a Nonresident Seller's Permit (S). Permit authorizes out-of-state brewer to sell ale or malt liquor to Texas permittees qualified to import. Nonresident Brewer must also hold Nonresident Seller's Permit. The permit holder may contract with the holder of a Nonresident Brewer's Permit to provide brewing services or for the use of the permit holder's brewing facilities under an alternating brewery proprietorship. Permit Fee: \$3,376

NONRESIDENT MANUFACTURER'S LICENSE (BS)

License authorizes the holder to transport beer into Texas only to holder of Importer's Licenses. The licensee may contract with the holder of a nonresident manufacturer's license to provide manufacturing services or for the use of the license holder's manufacturing facilities under an alternating brewery proprietorship or contract brewing. License Fee: \$2,076



MISCELLANEOUS PERMITS



PROMOTIONAL PERMIT (PR)

Permit authorizes the holder, on the behalf of a distiller, brewer, rectifier, manufacturer, winery or wine bottler with whom they have entered into a contract for the purposes of Chapter 50 of the Alcoholic Beverage Code, to engage in activities to promote and enhance the sale of an alcoholic beverage in this state, including activities that take place on the premises of the holder of a permit or license issued under the Alcoholic Beverage Code. Permit Fee: \$976



CARRIER'S PERMIT (C)

Permit authorizes holder to transport liquor into and out of this state and between points within Texas. Permit Fee: \$312



PASSENGER BUS PERMIT (PB)

Permit authorizes a corporation operating a commercial bus service to sell or serve alcoholic beverages while operating in or through the State of Texas. Permit Fee: \$1,000



EXCURSION BOAT WINE AND BEER RETAILER'S PERMIT (V)

Permit authorizes excursion boat to sell and serve beer and wine up to 14% or 17% (Section 251.81) for consumption on the excursion boat while operating in a wet area. Permit Fee: \$813



PASSENGER TRAIN BEVERAGE PERMIT (PT)

Permit authorizes a corporation operating a commercial passenger train to sell or serve alcoholic beverages while operating in or through the State of Texas. Permit Fee: \$1,602



AIRLINE BEVERAGE PERMIT (AB)

Permit authorizes a corporation operating a commercial airline to sell or serve alcoholic beverages while operating in or through the State of Texas. Permit Fee: \$4,727
